#### 4.1 Closing Date for Entries

Wednesday, 27th October, 2021, at 18:00hrs

#### 4.2 Entry Procedure

FIA competition license-holders wishing to take a part in the Kuwait International Rally 2021 must send their Entry Form duly completed, and accompanied by the total entry fees (*Article 24.1 of the 2021 FIA Regional Rally Sporting Regulations*), before the closing date of entries to the Rally Secretariat at the following address:

- **4.2.1** Competitors, drivers and co-drivers who wish to take part in the Kuwait International Rally 2021 can only do so with the approval of their own ASN, either by a specific written authorisation from their ASN, by statement authorising their participation printed on their competition license or obtaining its stamp on the entry form.
- **4.2.2** In compliance with Article 22.1 of the 2021 FIA Regional Rally Sporting Regulations An electronic entry application (Internet) may be accepted. If the application is sent by fax, by email or made electronically, the original duly signed entry form must reach the organisers within 5 days following the close of entries. The entry form must be accompanied by a copy of the valid competitor's licence.

#### 4.2.3 Competitors and crew members undertaking

By the very fact of signing the entry form, the competitors submit themselves to the sporting jurisdictions specified in the Code and its appendices, the 2021 FIA Regional Rally Sporting Regulations and these Supplementary Regulations.

In order to score points in the MERC, competitors must register with the FIA, by

using the registration form which can be found at https://registrations.fia.com/rally, before the end of administrative checks of the first rally in which the competitor

wishes to participate. However, points will not be awarded retrospectively.

#### 4.3 Number of entrants accepted and classes

**4.3.1** The maximum number of entries is 50. If more than 50 entries are received, the Organisers reserve the right to decide which entries (among the non-priority drivers) to be accepted.

#### 4.3.2 Eligible Cars and Classes

#### 4.3.5 Additional Provisions

In accordance with Article 12.2 of the 2021 FIA Regional Sporting Regulations:

- Cars homologated as Kit Car and Super 1600 are not allowed.
- For drivers entered with a Rally2 car complying with 2021 Appendix J, Art. 261, it will be possible to use the old part after applying a joker (except reliability and safety jokers).
- For drivers entered with a Super 2000-Rally car complying with 2013 Appendix J, Art. 255A, it will be possible to use lapsed errata without any penalty.
- An FIA technical passport is mandatory for S2000, Rally2 and RGT cars.
- RGT cars in compliance with 2019 Appendix J, Art. 256 must have a valid FIA RGT technical passport.

#### 4.3.6 National/Regional Cars

In accordance with Article 12.3.6 of the 2021 FIA Regional Rally Sporting Regulations, ASN-approved cars:

- will be permitted to take part and be shown in the entry list.
- The drivers and co-drivers of such cars score points in FIA Middle East Rally Championship.
- These cars must, however, comply with the safety requirements as stipulated in Appendix J, Article 253.

#### 4.4 Entry Fees:

#### 4.5 Payment:

The entry application will only be accepted if accompanied by the full entry fees, or by a receipt issued by the Competitors National Sporting Authority. Any entry form not fully completed or which is not covered by full payment of the fees will be refused.

#### cancelled by either of the above parties.

#### 4.6 Refunds:

Entry fees will be refunded in full:

- To candidates whose entry has not been accepted.
- In the case of the rally not taking place.

The organisers may refund 50% of the entry fee to those competitors who, for reasons of force majeure (duly certified as such by their ASN), were unable to start the rally.

#### 5. INSURANCE:

**5.1** As part of the entry fee competitors will receive limited cover for civil liability towards third parties in accordance with the traffic laws of Kuwait. This cover will include all crews running within the itinerary of the rally and will come into effect from the start of the first competition element until the end of the rally or at the moment of permanent retirement or exclusion.

The general conditions of the policy will mainly stipulate that the coverage is granted up to an amount of  $130,000 \notin$ , as far as bodily injuries or death is concerned.

- **5.2** In addition to the insurance cover provided by the organiser, all competitors are required to provide their own insurance covering all cars used in Kuwait to cover civil liability towards third parties for the entire duration of their visit in the case of foreign crew, or permanent cover in the case of Kuwaiti residents. A written copy of such insurance cover must be presented to the organiser.
- **5.3** The service vehicles and cars used for reconnaissance, even those bearing special plates issued by the organiser, are not covered by the insurance policy of the rally.
- **5.4** In compliance with Article 21 of the 2021 FIA Regional Rally Sporting Regulations. The laws of the State of Kuwait will be complied with in relation of procedures at accidents.

#### 6. ADVERTISING AND CAR IDENTIFICATION:

#### 6.1 ADVERTISING:

- a) Advertising is permitted on the car, including the roof. Advertising on windows is prohibited, with the exception of a maximum 10 cm high strip on the windscreen.
- b) Advertising of alcoholic or tobacco products or any advertising that is prohibited by the Kuwait law or which may cause offence is not permitted.
- c) Competitors who accept the organisers optional advertising must reserve on each side of the car 1 (A4) size space as indicated in the diagram

displayed in Appendix 4 hereafter, details of which will be announced in a bulletin.

- d) In compliance with Article 29.1 of the 2021 FIA regional Rally Sporting Regulations, competitors are allowed to affix any kind of advertising to their cars, provided that:
  - It is authorised by the national laws and the FIA regulations.
  - It is not likely to give offence.
  - It is not political or religious in nature.
  - It respects the regulations on competition numbers.
  - It does not interfere with the crew's vision through the windows.
  - It complies with the provisions of Article 10.6.2 of the Code.

#### 6.2 COMPETITION NUMBERS:

The Organiser will provide each crew with rally plates and number identification in compliance with article 27 of the 2021 FIA Regional Rally Sporting Regulations. These plates should be affixed to their car as specified in Appendix 4 prior to scrutineering.

#### 6.3 MISSING OR COVERING PLATES:

The missing and/or covering a rally plate or a group sticker will result in a cash penalty of 200  $\notin$  for each missing/covered plate or sticker.

#### 6.4 DRIVER'S AND CO-DRIVER'S NAMES:

The first initial(s) and surname of the driver and the co-driver, as well as the national flags of the country of the ASN from which they have obtained their licences, must appear on the rear side window on both sides of the car, adjacent to the competition number. The names must be:

- In white Helvetica.
- In upper case for the initial(s) and first letter of each name with the remainder in lower case.
- 6 cm high and with a stroke width of 1 cm.

The driver's name shall be the upper name on both sides of the car.

#### 7. TYRES:

7.1 All tyres must comply with Article 13 of the 2021 FIA Regional Rally Sporting Regulations read in conjunction with Appendix V of the 2021 FIA Regional Rally Sporting Regulations.

Gravel tyres must be used for the duration of the rally.

#### 7.2 Tyre Quantities

The overall quantity of tyres for use at the Kuwait International Rally 2021 is:

- For competitors entered with RC2 and RGT cars, a maximum of 18 tyres may be used during each rally.
- For competitors entered with RC3, RC4 and RC5 cars, a maximum of 14 tyres may be used during each rally.

#### **7.3** Reconnaissance tyres are free.

#### 8. FUEL - REFUELING

- **8.1** In compliance with the 2021 FIA regional Rally Sporting Regulations All type of fuel must be in compliance with Appendix J Art. 252.9.
- **8.2** Except as detailed in Article 58 (*i.e.: the change of a fuel tank*), and in accordance with Article 61 of the 2021 FIA Regional Rally Sporting Regulations, competitors may refuel only in the refuelling zones designated by the organisers.
- **8.3** Only actions inside the refuelling zone that are directly involved in the refuelling of the competing vehicle are permitted. Other activities are strictly prohibited.
- **8.4** The refuelling procedure will be carried out in accordance with Article 61 of the 2021 FIA Regional Rally Sporting Regulations.
- **8.5** The organisers may make provisions for additional refuelling zones. However, these additional zones shall only be positioned along the itinerary.

Any breach of these rules will result in a penalty at the discretion of the Stewards, which may go as far as disqualification

#### 9. RECONNAISSANCE

#### 9.1 Procedure for registration:

- a) Reconnaissance will be run in accordance with Article 35 of the 2021 FIA Middle East Rally Championship.
- **b)** Reconnaissance Cars must be in conformity with Article 35.1 of the 2021 FIA Regional Rally Sporting Regulations, and must be covered by insurance as required by the traffic laws of Kuwait, no responsibility being imputable to the organisers.
- c) When registering for reconnaissance one of the crew members must be present to sign an indemnity and register the details of the reconnaissance car, mobile telephone number and contact details.

The Reconnaissance Registration Form can be collected from the Rally Secretariat or downloaded from the Kuwait International Rally official website. This form should be filled and submitted to the Rally Secretariat by 18:00hrs on Thursday, 4<sup>th</sup> November, 2021 at the latest.

#### 9.2 Specific, national restrictions and speed limit on the special stages

a) In compliance with Article 35.3 of the 2021 FIA Regional Rally Sporting Regulations; as from the publication of the rally Supplementary Regulations, the presence of any driver, co-driver, or any other team member, who has entered rally, on any part of any special stage to be used in the rally will be reported to the Stewards who may impose penalties which may go as far as disqualification. Moreover, the involved competitor/crew, will be reported to their relevant ASN which will take appropriate

sanction.

- b) It is emphasized that reconnaissance is not practice. The competitors must drive in a manner that does not endanger or cause inconvenience to traffic or people living near the stages. All road traffic laws of Kuwait must be strictly complied with and the safety of other road users must be respected.
- c) Reconnaissance car identification numbers must be attached to the front windscreen (top center) and on the right and left rear side windows. They must be kept visible for the duration of the reconnaissance period.
- d) Crews are required to present their Reconnaissance time card at the Start and Finish of all Special Stages.
- e) Crews are authorised to drive a maximum of 2 (two) times through each Special stage during the Reconnaissance period in accordance with the timetable shown in the Rally Guide. Cars will only be permitted to enter and leave the special stages through the Start and Finish controls, and are forbidden to drive in the opposite direction of the rally route on special stages.
- f) In compliance with Article 34.2.2 of the 2021 FIA Regional Rally Sporting Regulations, speeding during reconnaissance will incur a fine applied by the clerk of the course as follows:
  - €25 per km per hour over the speed limit

The amount of the fine will be unaltered by any fine imposed by the police. The fine will be doubled in case of a second offence committed during reconnaissance in the same rally.

Other traffic infringements during reconnaissance will incur a penalty at the discretion of the Stewards according to Art. 34.3.4 of the 2021 FIA Regional Rally Sporting Regulations.

#### 9.3 Location of collection of GPS tracking and speed control checking devices:

a) The collection of GPS tracking units will take place on Thursday, 11<sup>th</sup> November, 2021, during the scrutineering. The Reconnaissance GPS tracking units should be operational at all time during reconnaissance.

It is the competitors' obligation to provide their reconnaissance vehicles with the necessary power source required for the GPS tracking system.

- b) The maximum speed limit of 80 km/h is imposed on all special stages during Reconnaissance unless the Organisers introduce a lower speed limit. Speed will be monitored by the GPS tracking devices carried by all reconnaissance cars.
- c) Any infringement of the reconnaissance regulations will be reported to the Stewards who may impose penalties at the discretion

#### 9.4 Schedule:

Reconnaissance will take place between 07:00hrs and16:00hrs on Wednesday, 10<sup>th</sup> November, 2021 in accordance with the schedule in Appendix 2 hereafter

The Competitors should always follow the Marshals' instructions.

#### **10. ADMINISTRATIVE CHECKS:**

#### 10.1 Documents to be presented:

- Competitors license (if any).
- Drivers and Co-drivers competition licenses.
- Driver's & Co-Driver's valid driving license.
- Driver & Co-Driver Passports or identification.
- ASN authorisation, for all foreign competitors and/or drivers
- Completion of all details on the entry form.
- Rally car registration papers.
- Valid car insurance coverage certificate towards the third party.
- A letter from the owner of the car and/or Power of attorney if the car is NOT property of entrant/driver.
- Driver's and Co-driver's medical certificate of aptitude (if not certified on the competition licence).
- Original FIA Homologation forms for the car entered.
- Technical Passport for S2000, Rally2 and RGT cars.

#### 10.2 Location& Time Table:

The administrative checks will take place at the Rally Headquarters located at the Seashell Julaia Hotel & Resort between 15:00hrs and 18:00hrs on Tuesday, 9<sup>th</sup> November, 2021, according to a time schedule that will be issued later in a bulletin and posted on the official notice board.

Drivers and co-drivers are not required to report personally to the administrative checks.

Each Competitor may nominate in advance an authorised representative, to the Rally Organiser, to complete administrative checks.

All documents, materials, numbers and plates, in addition to road books, will be distributed during the administrative checks.

Competitors' representatives reporting outside their time limits will be penalized **15**  $\in$  per minute to a maximum of 15 minutes. Thereafter, the represented competitor will be reported to the stewards who may apply penalties at their discretion.

#### **11. SCRUTINEERING, SEALING AND MARKING:**

#### 11.1 Scrutineering venue & time table:

The Scrutineering, marking & sealing will take place at the Service Park located at the Seashell Julaia Hotel & Resort between 09:00hrs and 12:00hrs on Thursday, 11<sup>th</sup> November, 2021, according to a time schedule that will be issued later in a bulletin and posted on the official notice board.

The FIA Technical Delegate is in charge of cars eligible to score points in the FIA Middle East Rally Championship only.

Drivers and co-drivers are not required to report personally to the scrutineering.

Each Competitor may appoint in advance, maximum, 2 people for the car(s) to complete scrutineering.

PPE or Medical Face Masks are required for all individuals entering the scrutineering venue.

Competitors' representatives reporting outside their time limits will be penalized  $15 \in$  per minute to a maximum of 15 minutes. Thereafter, the represented competitor will be reported to the stewards who may apply penalties at their discretion.

#### 11.2 Mud flaps

It is permitted to fit transverse mud flaps in conformity with Appendix J, Article 252.7.7.

#### 11.3 Windows/Nets

The use of tinted, silver or safety film is permitted on the side & rear windows.

In compliance with Appendix J article 253.11 the use of transparent and colourless antishatter films (maximum thickness: 100 microns) is compulsory on side and sunroof windows, unless they are in polycarbonate.

However, the use of silvered or tinted films, on the rear side windows, on the rear window and on the sunroof, in replacement of transparent and colourless anti-shatter films, is authorised. In such cases it must be possible for a person situated 5m from the car to see the driver as well as the contents of the car.

### 11.4 Driver's safety equipment

- 11.4.1 At Scrutineering, competitors must present all items of clothing including helmets and the head restraint (FHR device) intended to be used. Compliance with ISC, Appendix L Chapter III will be checked. Each helmet used by the crew will be identified & marked during the scrutineering; this marking may be checked on the start and the finish of each special stage.
- **11.4.2** in compliance with Appendix L, Chapter III, the wearing of a FIA approved Frontal Head Restraint (FHR), homologated according to the FIA 8858 standard and the wearing of overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to FIA 8856-2000 standard or FIA 8856-2018 standard are MANDATORY to be worn on special stages by all drivers and co-drivers
- **11.4.3** Where the occupants' bodies could come into contact with the safety cage, tubes of the cage and all roof reinforcements must be fitted with flame retardant protective padding in compliance with FIA standard 8857-2001 type A; refer to Technical List No. 23. Each padding must be fixed in such a way that it is not moveable from the tube.
- 11.4.4 In compliance with Article 53.2.2 of the 2021 FIA Regional Rally Championship Regulations each competing car shall carry a red "SOS" sign and on the reverse a green "OK" sign measuring at least 42 cm x 29.7 cm (A3). The sign must be placed in the car and be readily accessible for both drivers.
- **11.4.5** Each competing car must carry a red reflective triangle in compliance with Article 53.2.3 of the 2021 FIA Regional Rally Championship Regulations.
- 11.4.6 In accordance with the traffic laws of Kuwait, carrying a first aid kit on board the car is compulsory.

Any breach of these rules will result in refusal to take the start.

11.5 Noise level: No controls on this item.

#### 11.6 Scrutinering requirements:

- **11.6.1** Cars must be presented to the scrutineers with the rally plates & competition numbers affixed. Optional advertising should also be affixed on the car prior to entering the scrutineering venue.
- **11.6.2** Car's chassis and engine will be marked as prescribed in Article 31.1 of the 2021 FIA Regional Rally Sporting Regulations. Sealing of the cars' mechanical components (fitted on the cars and spares) will be carried out according to Article 16 of the 2021 FIA Regional Rally Sporting Regulations,
- **11.6.3** It is compulsory for the competitor/crew representatives to present:
  - the cars' complete original FIA homologation form and appendices,
  - a FIA technical passport for S2000, Rally2, and RGT cars,
  - an authentic copy of the homologation document or certificate, of the rollcage approved and signed by qualified technicians representing the manufacturer.
- **11.6.4** In accordance with appendix J, Article 253.6, two belt cutters must be carried on board at all times. They must be easily accessible for the driver and co-driver when seated with their harnesses fastened.
- **11.6.5** The installed extinguishing systems and manual extinguishers of the competing cars will have to comply with the regulations of Appendix J, Article 253.7.
- 11.6.6 Approved safety fuel tanks (FT3-1999, FT3.5-, or FT5-1999) and connections that are in compliance with the specifications set in Article 253.14, Appendix J of the 2021 FIA International Sporting Code are mandatory for all vehicles.
- **11.6.7** Underbody protection is permitted.

#### 11.6.8 2-way radios:

2-way radios are only permitted to operate on government controlled and designated frequencies.

**11.5.9** The air intake may be supplemented by means of a snorkel.

#### 11.6.10 On board cameras:

For use of onboard cameras, videos or films, an application form must be filled and submitted for approval by the organiser, it is mandatory to provide the organisers with a <u>COMPLETE NOT EDITED copy</u> of the recordings upon requisition.

#### 11.7 Installation of Safety Tracking System

- **11.7.1** In compliance with Article 53.6 of the 2021 FIA Middle East Rally Championship, live satellite or GSM tracking, data recording and emergency signalling devices will be used to monitor the position, movement and status of all competing cars at all times during the rally.
- **11.7.2** Competing cars will be fitted with data logging and tracking devices while scrutineering. Those devices will give an accurate trace of the position, movement and status of all competing cars during special stages and road sections of the rally.
- **11.7.3** information about handling and using the devices will instantly be given
- 11.7.4 Any attempt to tamper with or to interfere with the data recording devices

fitted to competing cars, or any device that fails to record a trace due to interference by the crew, will be reported to the stewards, who may impose a penalty that may go as far as exclusion.

**11.7.5** Any deviation will be reported to the Stewards, who may impose penalties at their discretion.

After scrutineering, if a car is found not in compliance with technical and/or safety regulations, the stewards may set a deadline before which the car must be made to comply, or may refuse the start.

#### **12. OTHER PROCEDURES:**

#### 12.1 Ceremonial Start procedure and order:

12.1.1 Location: Beach Side, Seashell Julaia Hotel & Resort

Date: Thursday, 11<sup>th</sup> November, 2021.

Time: at 17:30hrs.

The Ceremonial Start will be run in accordance with Article 39 of the 2021 FIA Regional Rally Sporting Regulations.

All competing cars are required to enter the Ceremonial Start Parc Fermé between 16:00hrs and 16:30hrs. A penalty of  $25 \notin$  per minute will be imposed for late arrival to a maximum of 15 minutes, thereafter; they will be reported to the stewards who may apply penalties at their discretion.

A representative of the competitor may deliver the car to the Start Holding Area.

The ceremonial start will be carried out in a descending numerical sequence, from last to first. The Ceremonial Start List will be published on the official notice board.

Competitors shall follow the officials' directions at the holding area.

The time interval at the Ceremonial start is 1 minute for all drivers.

Competitors are required to wear their approved overalls.

Competitors reporting late to the Ceremonial start will be penalized  $25 \in$  per minute to maximum of 15 minutes. Thereafter, they will be reported to the Stewards who may apply penalties at their discretion.

#### 12.1.2 Official Start:

The Start of the Rally will take place on Friday, 12<sup>th</sup> November 2021, at 09:30hrs, from TC0 located at the Parc Fermé.

Competing cars must enter the Start Parc Fermé located in Seashell Julaia Hotel & Resort, between 08:30hrs and 09:00hrs.

A representative of the competitor may deliver the car to the Start Parc Fermé.

Competitors reporting late to the start area will be penalized 25 € per minute to a maximum of 15 minutes. Thereafter, article 40.2 of the 2021 FIA Regional Rally Championships Regulations will apply.

#### 12.1.3 Starting order and interval:

- a) The starting order will be determined as follows:
  - FIA priority drivers

- MERC priority drivers
- Other drivers
- Drivers with National Cars
- b) All drivers will be granted an interval of three minutes (3min).

#### 12.2 Electronic start procedure

The time keeping of the Special Stages will be carried out to the 1/10<sup>th</sup> of a second. The start of the Special Stages will be carried out by an electronic countdown system placed on the right side of the road, between 2 & 5 meters ahead of the starting line, counting down by seconds and clearly visible to the crew from the start position. The electronic countdown system is as follows:

- 30 seconds before the start time: RED LIGHT
- 15 seconds before the start time: AMBER + RED LIGHT
- 5 seconds before the start time:
- Start Time:
- Start Time plus 20 Seconds:
- There will be a clock displaying time of day attached to the system

AMBER LIGHT

GREEN LIGHTS ON

GREEN LIGHTS OFF

- The entire system is driven by 1 chronometer.
- Refer to Appendix 7 hereafter.

The system is electronically coupled to a start line detection device placed 50cms after the start line (*RRSR*, *Art. 48.2.2*) that records any situation where a car leaves the start line ahead of the correct signal.

Should the above starting light panel fail to function; the start procedure will be given manually in accordance to Article 48.3 of the FIA 2021 Regional Rallies Championship Sporting Regulations.

#### 12.3 Finish Procedure:

The rally will conclude at the finish podium at the Finish Holding Area IN *(TC 10D)* located at the Beach Side, Seashell Julaia Hotel & Resort on Saturday, 13<sup>th</sup> November, 2021 at 16:25hrs.

Competitors shall follow the Officials' directions to the Finish ramp, directly followed by the adjacent Final Parc Fermé and/or Final Scrutineering.

Each crew may nominate a representative duly assigned in writing to take the car out of the Parc Fermé. In the event that the car is not drivable, this shall be reported to the Clerk of the Course and/or the Competitors Relations Officer who will arrange transport by recovery vehicle at the cost of the competitor.

#### 12.4 Permitted early check in:

Crews are permitted to check in early without incurring a penalty at:

- TC 6D End of Leg 1 Overnight Parc Fermé IN.
- TC 10D End of Leg 2- Finish Holding Area IN.

#### 12.5 Super special stage procedure and running order

Super special stage is not scheduled for the Kuwait International Rally 2021.

#### 12.6 Special procedures / activities

#### 12.6.1 Time card change during the rally

The Time Cards will be issued at the following time controls:

- Section 1 TC 0 Start Section 1 / Leg 1
- Section 2 TC 3B Regrouping OUT / Service A IN
- Section 3 TC 6E Start Section 3 / Leg 2
- Section 4 TC 8B Regrouping OUT / Service D IN
- Section 5 TC 10B Technical Zone OUT / Service E IN

#### 12.6.2 Re-Start after Retirement regulations:

Re-Start after retirement will be carried out in compliance with Article 54.2 of the 2021 FIA Regional Rally Sporting Regulations.

#### 12.6.3 Excessive speed during the rally / traffic laws

Throughout the rally, both crew members must observe the traffic laws of Kuwait.

Traffic infringements during the competition element of the rally will result in penalties in accordance with Article 34.3 of the 2021 FIA Regional Rally Sporting Regulations.

The amount of the fine will be unaltered by any fine imposed by the police.

#### 12.7 Official Time:

The official time throughout the rally will be the rally office clock which is calibrated and based on GPS time (UTC +3 hours).

#### 12.8 Other Provisions:

- **12.8.1** Visas are required for most nationalities to enter Kuwait. Competitors requiring assistance in obtaining visas must notify the organiser at least 21 days prior to their arrival. Assistance cannot be guaranteed if this notice is not received in time.
- **12.8.2** Competitors are responsible for clearing their own cars and spare parts through customs. Where possible, assistance may be given, however at least 14 days' notice should be given if assistance is required.

Cars subject to final checks (decision by the Stewards upon the recommendation of the FIA Technical Delegate) must have one representative for the entrant as well as two mechanics with their appropriate tools, in case of dismantling, present at the final check.

#### 15.2 Protest deposit fees

**15. FINAL CHECKS:**

a) All protests must be lodged in writing and handed to the clerk of the course together with the protest fee of 1000 €, which shall not be returned if the protest is judged unfounded.

If the protest requires the dismantling and the re-assembly of different parts of a car, the claimant must pay an additional deposit:

 i) If the protest involves a clearly defined part of the car (engine, transmission, steering, braking system, electrical installation, body, etc.): 750 € for each part.

- b) The expenses incurred by the work and by the transport of the vehicle shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if the claim is upheld.
- c) If the claim is unfounded, and if the expenses incurred by the protest (scrutineering, transport etc.) are higher than the guarantee deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned to them.

# Appendix 5 Extracts from FIA Appendix L

#### 1- Helmets (Appendix L, Chapter III, Art. 1)

When the use of an FHR, according to Article 3 below, is mandatory, drivers competing on rally special stages, registered on the FIA Calendar, must wear crash helmets homologated to one of the following FIA standards:

- 8858-2002 or 8858-2010 (Technical List N°41),
- 8859-2015 (Technical List N°49),
- 8860-2010 (Technical List N°33), or
- 8860-2018 or 8860-2018-ABP (Technical List N°69)

No helmet shall be modified from its original specification as manufactured, except in compliance with instructions defined by the manufacturer. Accessories must be fitted in accordance with the helmet manufacturer instructions. Only accessories approved by the FIA shall be used. Any other modification or addition of non-approved accessories (helmet cameras, visors, etc.) will render the FIA helmet homologation void.

### 2- Flame-resistant clothing (Appendix L, Chapter III, Art. 2)

On special stages of rallies, all drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (*Technical List N°27*) or FIA 8856-2018 standard (*Technical List N°74*).

Embroidery sewn directly onto the overalls shall be stitched onto the outermost layer only, for better heat insulation. Backing material of badges and thread used for affixing them to the overalls must be flameproof.

Substances which may circulate in any cooling system worn by a driver are restricted to water, or air at atmospheric pressure. Water systems must not require the saturation of a garment in order to function.

#### 3- Frontal Head Restraint (FHR) (Appendix L, Chapter III, Art. 3)

The wearing of any device intended to protect the head or neck and attached to the helmet is prohibited, unless the device has been homologated according to the FIA 8858 standard. Homologated FHR systems are listed in the FIA Technical List N° 29.

FHR systems must be worn only with FIA-approved items according to the following chart:

Helmet	Tether system (tether, tether end fitting and helmet anchorage)
FIA 8860 (Technical List № 33 & 69) FIA 8858 (Technical List № 41) FIA 8859 (Technical List № 49)	FIA 8858 (Technical List № 29)

#### 4- Safety Belts (Appendix L, Chapter III, Art. 4)

Drivers must be properly restrained in their seat by safety belts in conformity with the technical regulations for the vehicle concerned, at all times during a competition when it is mobile on a circuit, pit lane, special stage or competition course.

#### 5- Wearing of jewellery (Appendix L, Chapter III, Art. 5)

The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.

#### 6- Biometric Devices (Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.


If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.


If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.
